

Dear Supplier Partner,

Please note that the contents of this communication are strictly confidential and should only be shared with those in your organisation who have a need to know of the information. The contents of this communication must not be disclosed to third parties without the prior written consent of Jaguar Land Rover Limited.

Jaguar Land Rover would like to remind the Supplier that its supply of the Goods and/or Services to us shall at all times remain pursuant to the Terms and Conditions in the relevant Purchase Order or Rate Agreement (as applicable) ("Existing Terms"), and the Supplier remains responsible for supply of the Goods and/or Services strictly in accordance with such Existing Terms. As such, any request by Jaguar Land Rover for the Supplier to confirm that they are ready for Brexit is made for information purposes only, and is not, and shall not be considered as, a waiver or amendment to the Existing Terms, or the Supplier's responsibilities thereunder.

On 31st January 2020, the UK left the EU and entered a transition period lasting until 31st December 2020. During this transition, all EU rules and regulations continue to apply to the UK. Following this, if no trade agreement "deal" has been made, the UK and the EU will be treated as separate territories for customs purposes and all trade will be completed under World Trade Organisation terms. In this scenario, from 31st December 2020 all parties moving goods across the UK/EU border will need to file appropriate customs declarations and follow the required processes. Jaguar Land Rover expects all of its suppliers to have prepared for such an eventuality and requires suppliers to confirm they have done so.

What action do you need to take for Jaguar Land Rover?

Please use the link below to complete the survey (this should only take 5 minutes) where you will be asked to confirm against your supplier vendor codes that your organisation, from **1st January 2021**, is able to continue supply unchanged and complete necessary customs processes where required according to the delivery and/or Incoterms in your contract of supply with JLR. If you are not ready, you will be asked to provide a date at which your organisation will be prepared.

Completion of this confirmation is mandatory. If you have previously responded against your parent code, we still require a response for the individual GSDB noted above.

We require this information to be completed by Friday 16th October 2020.
